Dear Kate,

I hope you are well.

I have spoken with Muir this afternoon. As you know, he is preparing for his appearance before the S&T Committee on Wednesday. I have checked the CCER website and the list of FOI and EIR requests for CRU that were supplied to us by UEA has not been updated.

You may recall that shortly after the publication of the report, UEA informed us that they had inadvertently left of an FOI/EIR request (which turned out to be from Mr Holland). They then sent us a revised version of the list (including Mr Holland's request - 08-31) and asked us to upload this in place of the existing list.

As Mr Holland has referred to this omission in his correspondence and letters of complaint to Muir, Muir is keen that this be rectified before the S&T evidence session.

I attach the revised version to be uploaded asap.

You might want to consider a form of words to go up alongside the new list e.g. 'Please note the addition of the 08-31 FOI request which was previously omitted due to an administrative error. The revision does not affect the conclusions or recommendations of the final report.'
